

Fulton Safety Committee report: January, 2008

Crime reports – Fulton, Linden Hills, Armatage, Kenny, Lynnhurst

December 11 Between 8 a.m. December 11 and 6 p.m. December 12, an unknown suspect entered a home on the 5100 block of Oliver in Lynnhurst and took unlisted items. There were no signs of forced entry to the house.

December 11 Between 9:30 a.m. December 11 and 7:30 a.m. December 12, an unknown suspect kicked in the side door of a garage on the 5600 block of Colfax in Kenny, broke windows of two vehicles parked inside, and took items, including a computer, from the vehicles.

December 11 At 7:50 p.m., officers were dispatched to a robbery of person at an address on the 5600 block of Colfax in Kenny. The victim declined medical treatment.

December 17 Between 11:35 a.m. December 17 and 7:30 a.m. December 18, an unknown suspect stole a vehicle which was parked on the street on the 4200 block of Xerxes in Linden Hills.

December 20 Between 10 p.m. and 6 a.m., an unknown suspect broke into a garage on the 5000 block of Morgan in Lynnhurst via the service door. No loss was listed.

December 23 Between 9 a.m. December 23 and 11:30 a.m. December 25, an unknown suspect forced entry to a home on the 4900 block of Washburn and took unlisted items.

December 27 At about 3:35 p.m., officers received information that a person with a warrant was at an address on the 4000 block of Zenith in Linden Hills. Officers arrested 18-year-old Alexa Christine Wyatt of 3432 Bryant Avenue South for a felony warrant.

December 28 Between 10:30 p.m. and 11 a.m., an unknown suspect stole a vehicle which was parked on the street on the 4700 block of Zenith.

December 29 Between 9 p.m. and 2 a.m., an unknown suspect entered a garage on the 4200 block of Washburn in Linden Hills through an open overhead door and took a bag containing a camping tent. The bag and tent were later recovered in the middle of the street.

December 31 At 7:40 p.m., officers arrested 42-year-old Nadew Hailu Shawel of Edina for shoplifting, giving police a false name, and three misdemeanor warrants and one gross misdemeanor warrant at France 44 in Linden Hills. Shawel has been arrested six times in Minneapolis in the past year for offenses including obstructing the legal process, violating his conditions of release, refusing to take a DWI test, driving without insurance and after his license was revoked, trespassing, loitering with intent to buy or sell narcotics, and possession of drug paraphernalia. Shawel, who also faces theft and receiving stolen property charges from Richfield and theft charges from Edina, was released from custody with no bail required on January 4 pending a January 18 court appearance. Shawel has 26 convictions in Minnesota dating back to 1995, including 8 for theft.

January 5 Between 12:30 and 2:00 a.m., an unknown suspect stole a vehicle which was parked on the street on the 4800 block of Irving in Lynnhurst.

January 6 At 10:20 p.m., an aggravated robbery of person was reported at 50th & Bryant in Lynnhurst.
